



Waiver, Release & Indemnification

In consideration of the acceptance of the undersigned's application and the permission to participate as a volunteer and/or competitor in the United Way Halton & Hamilton "BIG Red Run", and any or all of the following events: the 10K Fun Run, 5K Fun Run, 5k Trail Walk, Kids Fun Mudder and Obstacle course, Pre and Post Race Activities on **Sunday October 1st 2017** and any other 2017 United Way Halton & Hamilton Run activities that take place prior to or after the event (the "Event"), the sufficiency of which is hereby acknowledged, and his/her heirs, executors, administrators, successors and assigns, HEREBY RELEASE, WAIVE AND FOREVER DISCHARGE The Town of Milton, The Region of Halton, the Halton Regional Police, Firepower Kids, all sponsors and contributors, United Way Halton & Hamilton and its employees and volunteers, the United Way Halton & Hamilton Race Committee, and all other associations, sanctioning bodies and sponsoring companies, and all their respective agents, officials, servants, contractors, representatives, elected and appointed officials, successors and assigns (the "Released Parties") OF AND FROM ALL claims, demands, damages, costs, expenses, actions and causes of action, whether in law or equity in respect of death, injury, loss or damage to the undersigned's person or property HOWEVER CAUSED, arising or to arise by reason of the undersigned's participation in the said event, whether as a spectator, participant, competitor, volunteer or otherwise, whether prior to, during or subsequent to the Event, AND NOTWITHSTANDING that same may have been contributed to, or occasioned by, the negligence of any or all of the aforesaid Released Parties.

IT IS FURTHER ACKNOWLEDGED that the undersigned assumes all risk of personal injury, loss of life or property loss resulting from any cause whatsoever, including but not limited to the inherent risks of the activities which the undersigned may take part in while at the Event, or any activities that take place at the Event.

THE UNDERSIGNED HEREBY UNDERTAKES to HOLD AND SAVE HARMLESS and AGREES TO INDEMNIFY all of the aforesaid Released Parties from and against any and all liability incurred by any or all of them as a result of, or in any way connected with the undersigned's participation in the Event.

THE UNDERSIGNED AGREES that he/she has read and understands the aforementioned waiver. The undersigned further represents and warrants that he or she is of legal age of majority for the Province of Ontario, and is physically fit to assist/participate in the Event.
